Yoga for All Musicians Summer Retreat Terms and Conditions 2024

Payment Policy

In order to reserve a limited spot in the Yoga for All Musicians Summer 2022 retreat, multi-day participants must pay a non-refundable deposit of \$200. The remainder owed, as agreed upon by Yoga for All Musicians and the participant, must be paid in full by June 17th. If the participant fails to pay the full amount by that date, or agreed upon other/additional dates due to a payment plan or extenuating circumstances, Yoga for All Musicians reserves the right to open the participant's spot, without reimbursement, to another participant.

Cancellation Policy

Deposits are nonrefundable. If a participant cancels before June 1st, they will be refunded the full amount minus their nonrefundable deposit. If a participant cancels after June 1st, they will be refunded 50% of their amount paid minus their nonrefundable deposit. If a participant cancels after June 15th, they will not receive a refund.

Yoga for All Musicians reserves the right to cancel at any time. In this event, the participant will be given a complete refund. A refund will be credited back to the original payment method or card.

COVID Policies

Participants must agree to all updated COVID Protocols established by Yoga for All Musicians to protect the safety of the community and acknowledge that if participants do not follow the protocols, they may be asked to end your time at the retreat and the forfeiture of any amounts paid. All available COVID-19 vaccinations, without exemption, will be required. Yoga for All Musicians will continue to monitor the COVID-19 Pandemic and assess the safest protocols possible. These protocols are subject to shift based on the ever changing nature of the pandemic. Yoga for All Musicians agrees to communicate these policies and shifts prior to arrival, and with enough time for participants to take action. Yoga for All Musicians reserves the right to change any element of their COVID-19 protocol at any time. Participants are individually responsible for reviewing and understanding all policies before attending.

Recordings & Photography

Yoga for All Musicians reserves the right to record or photograph, in any manner or medium, throughout the retreat. By participating in the retreat participants agree that your voice, image, and likeness may be recorded or photographed. These shall constitute Yoga for All Musicians intellectual property, and may be used as determined by Yoga for All Musicians and Taylor Rossi, and their sole and reasonable discretion. The participants hereby grant to Yoga for All Musicians and Taylor Rossi the right and permission to use in perpetuity, their name name, likeness, image, voice, recorded voice, appearance, biographical information, statements, and/or testimonial(s) in any manner and in any media, now known or later developed, at any time, for Yoga for All Musician's business purposes, without review, permission, or compensation of any amount or kind whatsoever. Participants shall not hold Yoga for All

Musicians responsible for any liability resulting from the lawful use of your appearance in accordance with the terms of this section, or the recording and photographing activities described hereunder.

Force Majeure

Neither Yoga for All Musicians or any of its third-party providers shall be liable for any failure or delay in the performance of its obligations under the Agreement arising out of or caused, directly or indirectly, by circumstances beyond its reasonable control, including, without limitations, acts of God: natural disasters; wars; endemics or pandemics, riots, power failure, accidents, governmental actions.

Limitation of Liability

To the greatest extent permitted by law, in no event shall Yoga for All Musicians or its employees, suppliers, or owners be liable under contract, tort, strict liability, negligence or any other legal or equitable theory with respect to the retreat for any lost profits, or special, indirect, incidental, punitive, compensatory, or consequential damages of any kind whatsoever. Additionally, in no event shall Yoga for All Musicians be liable with respect to the retreat for any illness, personal injury, or other physical consequences. These limitations will only apply to the extent permitted by law and do not apply to death or personal injury resulting from Yoga for All Musicians' acts or omissions or to liability resulting from our gross negligence or willful misconduct.
